In the event that Mr. Daisuke Koriya becomes an outside Auditor, the Company will enter into an agreement with him in which the liability for damages under Article 423, Paragraph 1 of the Companies Act is limited to the minimum amounts specified in each item of Article 427, Paragraph 1 of the Companies Act.

# Proposal 5: Payment of Bonus to Directors and Auditors.

In consideration of the business result of the current term, the Company would like to pay Directors' and Statutory Auditors' bonus within the limit of \(\frac{\pmathbf{4}6}{500},000\) in total (\(\frac{\pmathbf{3}36}{3600},000\) paid for Directors' bonus to our seven Directors (including \(\frac{\pmathbf{2}}{2},400,000\) paid for outside Directors) and \(\frac{\pmathbf{1}0}{106},500,000\) paid for four Statutory Auditors' bonus) who has their offices as of the last day of 106th fiscal year.

A proposal is also made that Board of Directors shall decide the specific amount of bonus for each Director, and Board of Auditors shall decide the specific amount of bonus for each Statutory Auditors.
